- 1. The above mentioned client shall pay Pasadena-rePhotography (hereinafter "Photographer") for all extra costs that the Photographer may have for travel, meals, and parking in addition to all other reasonable and customary costs in order to complete this stated contract.
  - a. \$350 For Bronze Package
  - b. \$550 For Silver Package
  - c. \$800 For Gold Package
  - d. \$1,200 For Platinum Package
  - e. \$15 Per each additional photo
  - f. \$40 per each additional Aerial Photo
  - g. \$200 for added Video Tour
  - h. \$500 for added 360 Tour
  - i. \$150 plus hosting and domain name fees for personalized website and hosting
    - i. Website Includes:
      - 1. Unique web address (www.yourlistingsaddress.com)
      - 2. Image gallery of all the pictures of your listing
      - 3. Link to your virtual tour
      - 4. Contact form, so your clients can easily send you emails and questions through your website
      - 5. Unlimited amount of pages so you can have as much content or links as you need
- 2. The above-mentioned deposit is non-refundable and will be credited to the final total fee. If the Client does not show or changes the session the deposit will be lost. If the Photographer does not appear at the agreed location and time specified above, the deposit shall be refunded in full to the Client.
- 3. The Proof Photographs will be delivered to the Client via pixiest.com photo gallery. The Client will then provide the Photographer a list of proof images that final photographs shall be made and indicate the number along with format of the final photographs to be delivered for each individual proof image. The final images both print and web quality shall be delivered to the Client via Dropbox or wetransfer.com.
- 4. The Client will assist and cooperate with the Photographer in gaining the requested photographs, such as specifying the people and location to be photographed; assisting the Photographer in posing at the Photographer's direction; pre-session consultations, etc. The Photographer is not going to be responsible for photographs that are not taken due to the Client's failure to be cooperative and of reasonable assistance.

- 5. The Photographer keeps the copyright of all photographs and hereby issues the Client unlimited but non-exclusive rights to use or reproduce the purchased photographs.
  - a. Pasadena-rePhotography will not sell the rights or disclose the location of the clients listing without consent from the Client.
  - b. Pasadena-rePhotography may use any and all images for promotional use via web, print, or any other media from here after.
  - c. Client may use images for promotional uses via web, print or any other media from hereafter.
  - d. Client cannot distribute or sell the rights to the images without written consent from Pasadena-rePhotography.
- 6. If the listing is a commercial building or location, a permit to shoot must be provided by the Client by the agreed upon shoot date.
  - a. If a permit is not provided by the shoot date, all actions to photograph the location will be postponed and the deposit shall be lost.
- 7. All payments must be made within five working days of delivery of final images.
- 8. Proprietary Information
  - The original and all copies of the Photographs and related materials, whether copyright-ed or patented, will be considered confidential and proprietary information of the Photographer and will be and remain the sole property of Photographer. Client agrees to maintain the confidential and proprietary information in strict confidence. Client agrees to take all reasonable steps to safeguard the confidential and proprietary information from unauthorized disclosure, theft, and third party access.
  - The Photographs may not be sold, leased, assigned, sublicensed, or otherwise transferred, in whole or in part, un-less otherwise permitted in writing by Photographer. Client will not copy, modify, disassemble, decompile, or otherwise misuse the images.
